A one (1) week deposit per child is due with this application. If your child is enrolled for three (3) or less, then the full balance is due with this application. A payment of 1/3 of the balance is due by June 1, 2010. Another 1/3 payment is due by July 1, 2010. The final balance for the summer program is due by August 1, 2010. A \$35 late fee will be applied if payments are not made by the due dates. Any monies paid are non-refundable, even if you cancel registration. Payment may be made in the form of check, money order, debit card or automatic draft withdrawals. There will be a \$35 return check fee. Make all checks payable to Tooney Town and mail the application to the address below.

TOONEY TOWN EARLY LEARNING CENTER SUMMER FUN PROGRAM WAIVER

By signing the front of this application, you acknowledged that you have read and understand the following:

On behalf of my child, I accept and assume any and all risks associated with my child's enrollment and participation in this program and its activities. I or anyone acting on my child's behalf agrees that neither Tooney Town Early Learning Center is responsible for any accidents, injuries, and/or medical or dental expenses arising from my child's participation in the program. I agree to indemnify and hold harmless Tooney Town Early Learning Center from any and all claims, damages, costs, attorney's fee or damages of any kind arising from participation in any and all field trips by my child. In accordance with this agreement, I promise not to sue Tooney Town Early Learning Center or any of its employees from all claims of liability or expenses of any kind relating to my child's participation in the program.

I understand that if my child does not attend the program or is dismissed from the program for any reason, no part of my fee will be refunded. I agree that no reduction in the fee will be made for days missed, late arrivals or early departures. I also understand that if payment in full is not received and if legal action is necessary to collect any monies owed, I will be liable for any legal costs as a result.

I grant permission for my child to be transported on any Tooney Town Early Learning Center vehicle or any vehicle hired by Tooney Town Early Learning Center for the sole purposes of field trips or off-site activities that are directly related to the summer fun program. I also grant permission for my child to participate in all swimming, horseback riding or rock climbing activities that are a part of the summer program.

In the event of an emergency and I cannot be reached, I authorize the staff of Tooney Town Early Learning Center to provide immediate medical treatment for my child and I acknowledge that I will be responsible for any costs incurred as a result. I also authorize Tooney Town Early Learning Center to directly contact the other persons named on this form as emergency contacts.

I understand that my child may be prematurely terminated from the summer program at any time if any of the following circumstances arise: (1) non-payment, (2) dangerous or disruptive language or behavior involving another child, staff or classroom property or equipment, or (3) Tooney Town's inability to meet the needs of your child. Tooney Town will try to make provisions for the above circumstances; however in the event that a child is terminated from the program, all monies paid will be forfeited.

I also give my permission to Tooney Town Early Learning Center to photograph and/or video-record my child solely for the purposes of and/or use in publications to promote and/or market Tooney Town.
